

**Dear Bob,**

I want to write fan fiction. I think it would be great writing practice and I'd love to write about my favorite characters. My friend says it's illegal. Is it?

**Dear Reader,**

Are we defining "fan fiction" as stories using other writers' characters and backstories?

If so, then yes, you would be infringing the copyrights of the writers whose story elements you had borrowed.

I wouldn't necessarily call it "illegal", but it isn't something a copyright lawyer ... or a court of law ... would approve.

On the other hand, if you write only for your own amusement and professional growth, and do not seek to distribute or exploit your fan fiction stories commercially, then I don't see any actual harm in it.


